В	Agent details An applicant may, if he so wishes, employ an agent to act on his behalf. If this is the case his details must be provided in this section.	
D	Tree details The Tree Preservation Order ref No is the number specified in the Tree Preservation Order that would have been sent to the owner of the land. This number MUST be quoted.	
Е	Proposed works and specification Specify the exact works for which you are applying for consent. Give a full justification for the need to carry out the specified works.	
F	Give a full justification for the need to carry out the specified works. Ownership certificates The applicant must serve notice on all the owners of the land. You must also provide us with a certificate to show that you have done this. A copy of certificates A & B are incorporated into the application form. Others are attached to these notes. Choosing the correct certificate You must complete either certificate A or B. Certificate A Complete this if you are the sole owner of all the land involved in the application Certificate B Complete this if you know the names and addresses of all the owners of the land involved in the application.
